

IMPORTANT LEGAL NOTICE

ATTENTION: This legal notice applies to the entire contents of the Website under the domain name www.Colnevalleycarclub.org.uk (The Website for the Colne Valley Classic and Vintage Club) and to any correspondence by e-mail between us and you. Please read these terms carefully before using the Website. Using the Website indicates that you accept these terms regardless of whether or not you choose to register with us. If you do not accept these terms, do not use the Website. This notice is issued by The Colne Valley Classic and Vintage Club (hereinafter referred to as the **CVCVC**).

1. INTRODUCTION

- 1.2 By accessing any part of the Website, you shall be deemed to have accepted this legal notice in full. If you do not accept this legal notice in full, you must leave the Website immediately.
- 1.3 The CVCVC may revise this legal notice at any time by updating this posting. 2. LICENCE
